# E Function Description

## Power On and Power Off

Power On: When you starts up the engine, the dashcam powers on. Power Off: When you turn off the engine, the dashcam powers off.

- Make sure you have connected the dashcam to power according to Step 2 and Step 3 in Installation section.
- The power mode of cigarette lighter may vary by different vehicle types. Some may be powered constantly. In this case, please make sure that the dashcam stops after you turn off the vehicle engine. Otherwise, insufficient voltage may occur to vehicle battery.

#### Recording

Two recording types are provided: Normal Reording and Emergency Recording, Sound and mute recordings are selectable. Sound recording is set as default. You can turn off sound in app.

Disconnect cigarette lighter to avoid insufficient voltage and abnormal startup. Reconnect cigarette lighter to ensure dashcam work normally when you start the car again.
- Operating temperature is from -20°C to 70°C (-4°F to 158°F). To protect the dashcam. DO NOT use it in high temperature, low temperature, or high-humidity environment. Keep the dashcam from rain and dust.
- The manual is subject to update. The functions of dashcam may vary according to different models.
